Our terms are as follows:

Statements are done on the 25th of each month. Payment is due NET 10.

If payment is not received by the 25th of the following month, there will be a 1 ½ % finance charge per month (18% APR) added. If lack of payment still persists, you will be notified/warned in writing, then placed on "Credit Hold" until all past due balances are paid in full.

The applicant will be responsible for all invoices and agrees to our return policy, which is; 20% handling charge on returns with receipt and subject to approval from our office. There will be no returns on "special order" items.

The applicant agrees to pay all cost incurred to collect the account balance including, collection agencies, attorney fees, court cost and service charges.

Joe's Bldg. & Plmg. Supplies Inc. has the right to cancel your credit account at any time due to just cause.

If your company requires the use of purchase orders, you must notify us. If only certain people can sign on the account, you must notify us and supply us with a list of names.

If you are tax exempt, we need a tax exemption form submitted a.s.a.p. along with your ID#.
